

Polytechnic mentioned against his/her name.

The above appointment is made provisionally for the period of 1 (one) year from the date of joining the post of Lecturer at the concerned Polytechnic mentioned at Column-4 of the table above, pending receipt of Medical Examination and Report of Verification of antecedents & character (Police Verification Report) of the candidates by the competent Medical Board and Police Authorities concerned. In case, the PVR in respect of any candidate is found unsatisfactory by the concerned Police Authorities, the appointment in respect of the candidate is liable to be terminated forthwith without issuing any notice to him/her and/or without assigning any reason whatsoever.

4. The candidate concerned is liable to be transferred to any other Government Polytechnics in West Bengal as and when necessary.

The candidate concerned will report his/her duties in the post of Lecturer in Electronics and Instrumentation Engineering at the Polytechnic as mentioned at Col. 4 against his/ her name, within two months from the date hereof, if not extended by any special order in this effect, failing which his/her candidature is liable to be cancelled without assigning any reason thereof.
