**Sub.: Admission norms for Part-time Diploma Course in Electrical Engineering for 2018 – 19**

Technique Polytechnic, a self-financed Institute in West Bengal which earned NBA accreditation for their Diploma Course in Electrical Engineering obtained approval of the AICTE to run part time Diploma Course in Electrical Engineering.

In consideration of the above the Department of Technical Education Training & Skill Development hereby accords permission to Technique Polytechnic Institute to conduct part time Diploma Course in Electrical Engineering for the academic session 2018-19 on the following conditions:-

1. Part time Diploma Course in Electrical Engineering shall be of 4(Four) years duration.
2. In case of the part time Diploma Course in Electrical Engineering, 25% of approved intake will be Management Quota.
3. 75% seats will be filled up through counseling by the WBSCT&VE&SD.
4. Candidates passed 10<sup>th</sup> standard /SSC Examination and 2- year ITI after 10<sup>th</sup> standard or passed 10<sup>th</sup> standard/SSC Examination and minimum of 2 years' full time work experience in a registered firm / company / industry/ educational or Government/ autonomous organization in the relevant field in which admission is sought shall be eligible to apply. NOC from the employer of a candidate who is currently employed shall be a mandatory requirement. The candidates who are not currently employed but have two years full time work experience shall be required to submit relevant "Experience Certificate".
5. Merit list will be prepared on the basis of percentage of marks in aggregate obtained in the qualifying examination.
6. Tuition fee structure for the part-time Diploma Course shall be similar to that of full time Diploma Course for self-financed Polytechnics but spread over four years ie. Rs.1125/ per month for students admitted through counseling by WBSCT&VE&SD and Rs.1875/- per month for students admitted to management quota seats.
7. This permission shall be valid for the session 2018 – 19 only.


