## **ORDER**

The Department is implementing Vocational Education & Training Programme through Vocational Training Centers (VTCs) since 2005-2006 under affiliation of West Bengal State Council of Technical and Vocational Education and Skill Development (WBSCT&VE&SD) in Short-Term (VIII+ Level) 06(six) months duration Training Programme and H.S. Vocational courses. At present, 2714 no. of affiliated VTCs are operational.

Now, the undersigned is directed by the order of the Governor to say that the Governor is pleased to accord approval for 200 new VTCs for running 02(two) Short Term Training courses from the list of NQR registered 18(eighteen) nos. courses and 02(two) nos. of Vocational Education Programme at H.S Level of WBSCT&VE&SD in each VTC.

Recurring and one time Non-Recurring expenditure to the tune of Rs.11.55 Crore in the current Financial Year and Rs.9 Crore would be borne from the Head of A/c "2203-00-800-013-36-00" and "2203-00-800-013-31-02" respectively as per prevailing norms for VTCs.

WBSCT&VE&SD is requested to initiate affiliation process of the said 200 new VTCs as stated above as per prevailing norms of the Council with wide circulation in leading dailies and electronic media for seeking applications from the new centers to be affiliated .
