ORDER

The list of persons annexed herewith are engaged afresh to act as **Lower Division Clerk** in Government Polytechnic as mentioned against their names on purely contract basis for a period upto 31/12/2018 w.e.f. 04/09/2018 or till the post is filled up by regular candidates selected by the Public Service Commission, W.B. / Staff Selection Commission, West Bengal, whichever is earlier. When they join the respective Polytechnics, the Principal / Officer-in-Charge should make an agreement with the incumbent on Non-Judicial Stamp of any value as per pro-forma annexed herewith and confirmed by Notary Public / Magistrate of the first class. No such Contractual Lower Division Clerk will be transferred or deputed to the other Polytechnics or Directorates.

This order is issued with the concurrence of Finance Department vide their U.O. No. Group P2/2018-2019/0375 dated 25/07/2018.

Terms and condition for such engagement are given below :

1. The engagement is made on purely contract basis and his / her engagement shall automatically be terminated after expiry of his / her present term.
2. This engagement will not confer any right and claim to regular appointment / absorption in regular post of Government service.
3. An agreement is to be executed between the Principal / O.I.C. and the incumbent on Non-Judicial Stamp as per pro-forma annexed herewith and confirmed by Notary Public / First Class Magistrate is to be obtained from each of the engage on his / her joining the post and should be sent to this Department immediately after his / her joining.
4. Leave Rules of regular Government employees will not be applicable in this respect.
5. Consolidated monthly remuneration will be Rs. 8,000/-.
6. Engagement shall be terminated on unsatisfactory performance and / or involvement in any unlawful activity with one month's notice upon the incumbent.


