## **ORDER**

It has been decided that "Surrender-cum-Rehabilitation Scheme of Left Wing Extremists" will be implemented in this State with necessary financial assistance from the Government of India, vide this Department's Notification No. I/49406/2019 Dated 12/06/2019. As per para 4 of the said notification, if any prospective beneficiary does not possess minimum educational qualification, such beneficiary will be required to undergo a one-year pre-ITI foundation course.

Now, the Governor is pleased to order that a committee comprising of the following officers headed by the District Magistrate of the concerned district will prepare/ develop the Curriculum of the foundation course (pre-ITI foundation course) in the concerned district and also make the assessment of the trainees:

- 1. District Magistrate
- 2. Superintendent of Police
- 3. Project Director of District Rural Development Cell
- 4. Project Director cum District Welfare Officer
- 5. District Social Welfare Officer
- 6. District Labour Officer
- 7. Nodal Officer of Paschim Banga Society for Skill Development
- 7. The Principal of the concerned ITI (Convenor).

The aforementioned committee is also entrusted with the responsibility of ensuring completion of rehabilitation package by organizing wage employment or self employment under all Government programmes/ Govt. sponsored programmes.

Such ITI candidates will also be eligible for one year National Apprenticeship Promotion Scheme (NAPS).
