**Sub: Approval for engagement of Guest Faculties under CSS-VSE Scheme of Samagra Shiksha Abhiyan as stopgap measure for the interest of the students in Class IX-XII**

It has been reviewed by the Administrative Department that few schools are suffering from Teaching Learning process of Vocational Education & Training due to absence of Sector Specific Training Providers or non-availability of Vocational Trainers (VTs).

Considering the above fact, the undersigned is directed by the order of the Governor to say that the Governor is pleased to accord approval for engagement of Guest Faculties as stopgap measure for the interest of the present students by the Head of the respective schools on temporary basis till the engagement of Vocational Trainers by selected Training Providers is in place. Selection process for Guest Faculties will be followed as per norms laid down in SOP vide G.O. 42-TET(Poly)/2V-21/2016 dated 17.01.2017 with due diligence and name of candidate will be intimated to Directorate immediately after completion of selection process.

The Governor is also pleased to accord approval for releasing honorarium of Guest Faculty @Rs.500/- (Rupees Five Hundred Only) for 02(two) Hrs. Classes subject to maximum honorarium of Rs.20,000/- per month .

The said amount of honorarium of Guest Faculties may be transferred to the account of concerned schools for onward transmission to the Guest Faculties by Direct Beneficiaries Transfer based on requisition from respective schools in prescribed format including honorarium of Head of the Institute as per approved rate i.e. Rs.1,000/- per sector per school per month after completion of every month to the Directorate of Vocational Education & Training, West Bengal.

Utilisation Certificate of the said fund is to be furnished to this Directorate in due course before next requisition of fund.

This order is issued with the approval of the Competent Authority of this Department.
