In continuation of this Department Order No 1412-TET(Poly)/5P-10/2019 (Pt I) dated 24.12.2019, the undersigned is directed by order of the Governor to say that to protect the interest of the existing Principal of Govt. & Govt.-sponsored Polytechnics, the Governor has been pleased to incorporate the following provision in the Deptt. Order, referred to above.

The pay of the Principals, who are drawing AGP of Rs 10,000/- in the existing pay structure, shall be fixed in Level 13AI of the revised pay structure in the manner as shown in the sub-para 5 of Order No 1412-TET(Poly) dt 24.12.2019 by taking into account the AGP actually drawn i.e., Rs 10,000/-.

The Governor has further been pleased to direct that since the UGC has done away with the provisions of allowing incentives for Ph.D./M.Phil or any other higher qualification in the form of non-compounded advance increments, there shall be no incentive in respect of teachers of Polytechnics with effect from 01.01.2016 in the form of non-compounded advance increments for having / acquiring higher qualification like Ph.D., M.Phil., M.Tech. etc.

The order is issued with the concurrence of Finance Department vide U.O. No. Group P1/2019-20/0344 dated 07/01/2020.
