NOTIFICATION

Sub: Clarification on Certain Issues Regarding CAS Rules for Principals & Lecturers of Govt. and Govt. Sponsored Polytechnics.

Consequent upon AICTE's Regulation vide the Gazette of India: Extraordinary Part III – Sec. 4, New Delhi No. F. No. 61-1/RIFD/7th CPC/2016-17 Dated March 01, 2019 and subsequent Notification vide F. No. 61-3/RIFD/7th CPC/2016-17 Dated 20.05.2020 and in continuation with this Department's Order No. 1412-TET(Poly) Dated 24.12.2019 read with Order No.: 53-TET(Poly), Dated 20.01.2020, Corrigendum No. 60-TET(Poly) Dated 21.01.2020, Order No. I/210559/2022 Dated 31.07.2022 read with Corrigendum No.: I/378433/2023 Dated 21.03.2023 and Order No. I/382541/2023 Dated 30.03.2023, the undersigned is directed to state that the Governor has been pleased to accord approval for certain clarifications in respect of the CAS rules for Lecturers and Principals of Govt. and Govt. Sponsored Polytechnics.

A. Exemption from FDP, Industrial Training, 360⁰ Feedback and Research Publication for Faculty Members Engaged in Diverted Capacities/OSDs in various verticals of this Department:

Any Faculty Member who are engaged in diverted capacities/ OSDs in various verticals of this Department on academic / administrative positions for a period of not less than 3 (three) years on the due date of his/her eligibility for CAS benefits in each stage with SARs/ACRs having 'very good' remarks are exempted from the requirement of FDP, Industrial Training, 360⁰ feedback and research publication .


B. Authority for according Permission for FDP, Industrial Training, Research Publications, NET/SET/SLET:

Lecturers shall have to obtain permission for undergoing FDP, Industrial Training, for Research Publications and appearing NET/SET/SLET from the Appointing Authority / DTET mandatorily.

C. Movement from Level 9A to Level 10 on completion of five years of continuous and satisfactory service and the approving authority.

Movement may be considered synonymous with nonfunctional promotion. This Department may act as the approving authority after receipt of proposals through proper channel. Otherwise Finance Department may be requested to clarify the issue, if deemed fit.

This issues with the concurrence of Finance Department U.O. No. Group P1/2021-2022/0273 Dated 04.11.2021 and approval of the competent authority of this Department.
