MEMORANDUM

Whereas, the Public Service Commission, West Bengal for filling up the post of Lecturer in Electrical Engineering of Govt. Polytechnic under the West Bengal General Service in the vacancy of P.D.(L.D./C.P.) recommended the name of Shri Sudarsan Guria, S/o Sri Arabinda Guria, Pathuria, Asadtala, Nandigram, Dist- Purba Medinipur, PIN-721656, W.B. vide their Memo No. No.215-PSC (Selection)-1S-16/2018 dated 05/05/2021.

And Whereas, in terms of this Department's Order No. I/156280/2021 dated: 26/10/2021, Shri Sudarsan Guria, S/o Sri Arabinda Guria, Pathuria, Asadtala, Nandigram, Dist- Purba Medinipur, PIN-721656, W.B. was appointed provisionally to the post of Lecturer in Electrical Engineering of Govt. Polytechnic under the West Bengal General Service pending receipt of Medical Examination Report and Report of Verification of antecedents & character (Police Verification Report) by the Medical Board constituted for that purpose and concerned Police Authorities, respectively.

And whereas, subsequently, on receipt of the report of the Medical Examination in respect of Sri Sudarsan Guria, it appears that he has been declared 'unfit' by the Medical Board on account of below benchmark disability, although the Commission recommended his name against the vacancy of P.D.(L.D./C.P.).

And whereas, it is mandated by the West Bengal Service Rules that no person shall be appointed in a post without a medical certificate and here, Shri Guria having "below 40% disability (PHOH)" cannot be appointed in the respective vacancy meant for P.D.(L.D./C.P.).

Now, therefore, the undersigned is directed by order of the Governor to state that the Governor is pleased to terminate the provisional appointment of Shri Sudarsan Guria, for the post of Lecturer in Electrical Engineering of Govt. Polytechnic in the W.B.G.S. under the Department of Technical Education, Training & Skill Development, Government of West Bengal under sub-rule 2 of rule 34 of WBSR Part-1.

This shall be treated as one month's notice of termination with effect from the date of issue of this memorandum. This has the approval of the competent authority of this Department.
