The candidates mentioned above shall be initially appointed on probation from the date of joining and shall have to pass departmental examination within due time as per provision of West Bengal Service (Appointment, Probation, Confirmation) Rules, 1979. The candidates mentioned above will be declared confirmed in the service on continuous & satisfactory completion of the period of probation and after passing of the prescribed departmental examinations which is essential before confirmation as per the provisions of Chapter-I of the West Bengal Services (Training and Examination) Rules, 1953 and subsequent amendments.

The candidate concerned will report his/her duties in the post as mentioned at Col. 5 against his/her name, within two months from the date thereof, if not extended by any special order in this effect, failing which his/her candidature is liable to be cancelled without assigning any reason thereof.

The appointment shall be governed by the terms and conditions of the State Govt. Service Rules and all other rules and orders as are applicable to the State Government Employees of similar categories, shall also apply "Mutatis and Mutandis" in respect of the above mentioned candidates. All subsequent orders issued by the State Government apropos service terms, conditions, pay etc. shall apply on them.

Their inter-se-seniority will be determined subsequently.
