The Department of TET&SD, GoWB may at its discretion extend deadline for submission of quotation.

Terms & Conditions:

- 1. Payment Terms: 100% after delivery and installation on submission of invoice.
- 2. Installation Support: To be provided by the Symantec & Vendor.
- 3. Standard Support: To be provided by Symantec and Vendor which includes product & technical support, free updates, email, telephonic and web based support.
- 4. Period of Delivery of License: License should be delivered with 1 (One) month from the date of issue of Purchase Order.
- 5. Penalty Charge: The Vendor will bear the late penalty charges on actual (1% per week).

Penalty will be deducted at the final payment. Maximum cap on penalty is 5%.

- 6. Taxes: Taxes GST if applicable to be included in the cost. However, the quotation should clearly mention the basic price, GST Price per unit
- 7. Force Majeure Condition:
- The Vendor shall be liable for any delay in execution or failure of their respective obligations under this agreement except for delay caused by occurrence of events beyond control of the Vendor, including but not limited to natural calamities, fire, explosions, floods, power shortages, acts of God, hostility, acts of public enemy, wars, riots, strikes, sabotage, order/action or regulations of government, local or other public authorities.

In case a Force Majeure situation arises, the Vendor shall immediately notify the Department of TET&SD, GoWB in writing which should be duly acknowledged by the Department of TET&SD, of such conditions and the cause thereof within two calendar days and prove that such situation is beyond the control and affect the

implementation of the agreement.

Unless otherwise directed by the Department of TET&SD in writing, the Vendor shall continue to perform its obligations under the contract as far as it is reasonably practical, and shall seek all reasonable means for performance not prevented by the Force Majeure event.

Notwithstanding the above, the decision of the Department of TET&SD shall be

final and binding on the Vendor.

Note:

I . Prices should be quoted in Indian Rupees only with no conditions attached like Rs-\$ exchange rate, OEM policy, inflation factor.

2. The Competent authority reserves the right to accept or reject any quotations

without assigning any reasons.

3. The decision of the competent authority will be final and binding.

4. Any tenders which are incomplete or not as per the prescribed format will be summarily rejected.
